
Quiborax S.A., Non Metallic Minerals S.A. and Allan Fosk Kaplún v. Plurinational State of Bolivia

Claims arising out of the revocation by Presidential Decree of eleven mining concessions allegedly held by claimants through an investment vehicle in Bolivia. Claimants allege that the revocation of the Bolivian Concessions was a confiscatory measure.

On May 18, the International Centre for Settlement of Investment Disputes decided that Plurinational State of Bolivia have to pay to Quiborax S.A. and Non Metallic Minerals S.A. \$48.6 Million as compensation.
